NO EXPERIENCE IS NECESSARY TO MAKE A CAO ELITE TEAM.

WE WILL CONSIDER WHERE WE ARE THE MOST COMPETITIVE WITH TUMBLING, STUNTING, PERFORMANCE AND OVERALL ABILITIES TO CREATE TEAMS THIS SEASON.

WE FOCUS ON PROVIDING ATHLETES THE OPPORTUNITY TO BE AN ASSET ON THEIR TEAM AND BE USED THROUGHOUT THE ROUTINE BY PLACING THEM WHERE THEY CAN FULLY COMPETE AND PERFORM TO THEIR MAXIMUM POTENTIAL.

IT IS NOT ONLY IMPORTANT TO "LAND" A SKILL, BUT EXECUTE IT WHILE LANDING IT REPEATEDLY.

ATHLETES MUST PROVIDE A STRONG TECHNICAL STUNTING SKILLS AT THE REQUIRED LEVEL.

COACHES RESERVE THE RIGHT TO MOVE A CHILD TO A DIFFERENT TEAM DURING THE SEASON

I WILL NOT BE INVOLVED IN ANY MATTER OF DISRESPECT TOWARDS ANY MEMBERS OF THE CAO ELITE STAFF, PARENTS OR STUDENTS.

IF I HAVE ANY QUESTIONS OR CONCERNS THAT NEED IMMEDIATE ATTENTION I WILL USE THE FOLLOWING CHAIN OF COMMAND:

1. TEAM REP 2. HEAD COACH 3. ALLSTAR DIRECTOR 4. OWNER/PRESIDENT

ANYONE THREATENING TO QUIT OR PULL THEIR CHILD FROM A SQUAD MAY BE DISMISSED FROM THE PROGRAM IMMEDIATELY.

I UNDERSTAND THAT THE COACHES RESERVE THE RIGHT TO SUSPEND ANY ATHLETES OR PARENTS PARTICIPATION IN ACTIVITIES AT CAO ELITE OR AT CAO ELITE FUNCTIONS AS DISCIPLINARY ACTION.

DEPENDING ON ALTERNATE STATUS IS ESTABLISHED

THE GYM IS SUBJECT TO CHARGING YOUR ACCOUNT COMPETITION FEES FOR YOUR ATHLETE TO ATTEND EVENTS.

I WILL NOT PARTICIPATE IN NEGATIVE GOSSIP OR COMMUNICATIONS THAT ADVERSELY AFFECT CAO ELITE, ITS OWNERS OR STAFF.

I WILL NOT POST ANY NEGATIVE COMMENTS ON WEBSITES OR IN CHAT ROOMS.

I WILL NOT POST ANY CAO ELITE MUSIC, CHOREOGRAPHY, ROUTINES, STUNTS, ETC., ON ANY WEBSITE.

THIS INCLUDES "FACEBOOK," "TWITTER", "INSTAGRAM, "YOUTUBE" AND ALL OTHERS BEFORE THE END OF THE SEASON.

AS A PARENT, I WILL NOT HOLD OR THREATEN TO HOLD MY CHILD FROM PRACTICE OR COMPETITION AS A FORM OF PUNISHMENT.

I WILL CONDUCT MYSELF WITH RESPECT AND INTEGRITY, DISPLAYING POSITIVE SPORTSMANSHIP AT ALL TIMES.

I UNDERSTAND ALL ATHLETES AT CAO ELITE ARE EXPECTED TO ARRIVE AT PRACTICES AND COMPETITIONS WITH A POSITIVE ATTITUDE AND GIVE THEIR BEST EFFORT IN EVERY ENDEAVOR.

CHEERLEADERS MUST BE IN FULL UNIFORM AND MAKE UP

IF YOU ARE ASKED TO BE A CROSSOVER ATHLETE YOU WILL BE RESPONSIBLE FOR THE CROSSOVER FEES IN ADDITION TO YOUR REGULAR TUITION.

I UNDERSTAND THAT THE PARENT VIEWING AREA SHOULD BE A POSITIVE ATMOSPHERE

AND I MAY BE PROHIBITED FROM USING THE PARENT VIEWING AREA IF I CANNOT MAINTAIN A POSITIVE ATTITUDE WHILE THERE.

IF MY BILLING EMAIL ADDRESS CHANGES, IT IS MY RESPONSIBILITY TO NOTIFY THE CAO FRONT OFFICE OF THE CHANGE.

IF THE BID EVENTS ARE AFTER THE REGULAR SEASON ENDING-GYM FEES FOR COACHING AND FACILITY WILL BE CHARGED.

I UNDERSTAND IF A REFUND IS DUE TO ME IT WILL BE ISSUED TO ME IN THE FORM OF CREDIT ON MY ACCOUNT LEDGER ONLY

NO REFUNDS WILL BE GIVEN IN THE FORM OF CASH, CHECK, OR CREDIT CARD.

A: DEPENDS ON IF YOU ARE A NEW OR RETURNING PARENT. ALSO, THE TEAM YOUR CHILD MAKES. FOR EXAMPLE, FULL SEASON TEAMS GYMS FEES ARE \$150.00 DUE ON THE FIRST OF THE MONTH AND PARENT BOOSTER FEE IS \$150.00 DUE ON THE 20TH. THESE FEES ARE INCLUSIVE OF EVERYTHING EXCEPT UNIFORM, TRAVEL, HOTELS, TEAM GIFTS, SHOES AND PRACTICE WEAR. WORLDS TEAM WILL PAY MORE INTO BOOSTER TO COVER THE CHEERLEADING WORLDS COST.

Q: WHERE CAN I FIND ALL OF CAO ELITE PROTOCOLS AND PROCEDURES?

A: THE CAO ELITE HANDBOOK IS AVAILABLE IN THE MEMBERS SECTION OF THE WEBSITE AND EMAILED TO ALL REGISTERED PARTICIPANTS AFTER CAO ELITE TRYOUTS. WITHIN IT YOU WILL FIND ALL THE FORMS YOU NEED FROM ABSENT REQUEST TO APPLY CREDITS FORM.

Q: DOES CAO "CUT" CHEERLEADERS WHO TRY OUT?

A: NO! THERE IS A PLACE FOR EVERY AGE AND EVERY LEVEL OF ATHLETE AT CAO. EVERY ATHLETE WHO TRIES OUT WILL MAKE ONE OF OUR AWARD WINNING TEAMS. HOWEVER A PARENT INTERVIEW IS MANDATORY IN ORDER

Q: HOW MUCH DOES IT COST?

A: OUR MONTHLY TUITION IS \$150 A MONTH FOR ONE MEMBER, \$250 FOR TWO SIBLINGS AND \$350 PER MONTH FOR THREE SIBLINGS FROM MAY-MARCH. A COMPLETE BREAKDOWN OF COSTS WILL BE AVAILABLE AT YOUR PARENT INFORMATIONAL MEETING.

Q: HOW DO WE GET OUR UNIFORMS?

A: WE WILL HAVE OUR FIRST FITTING ON MAY 25 FOR THOSE THAT TRIED OUT AND HAVE PAID COMMITMENT FEES. THE FINAL UNIFORM FITTINGS WILL BE ON AUGUST 15TH. ALL FITTING DATES ARE MANDATORY AND A PARENT/GUARDIAN MUST BE PRESENT TO SIGN OFF. PRACTICE WEAR IS ORDERED BY PARENTS THROUGH OUR INFINITY STORE. PERFORMANCE WEAR AND COMPETITION UNIFORM YOU WILL RECEIVE BEFORE THE FIRST COMPETITION.

Q: WHEN CAN MY CHILD "MOVE UP"?

A: WE RESERVE THE RIGHT TO MOVE A CHILD UP OR DOWN AT ANY GIVEN TIME. HOWEVER, WE WILL RE-EVALUATE EVERY ATHLETE IN AUGUST TO DETERMINE IF A TEAM CHANGE NEEDS TO OCCUR WHETHER IT'S MOVING UP OR DOWN. ALL MOVEMENTS ARE FIRST FOR THE CHEERLEADER AND SECONDLY FOR THE PROGRAM TO BE AS COMPETITIVE AS POSSIBLE.

Q: HOW DO YOU SELECT TEAMS?

A: WE SELECT TEAMS TO BE THE MOST COMPETITIVE IN EACH LEVEL.

Q: CAN MY DAUGHTER FLY?

A: IF THE COACH FEELS THAT YOUR DAUGHTER SHOULD BE A FLYER, SHE WILL BE.

Q: WHAT SHOULD I WEAR TO TRYOUTS?

A: ATHLETES SHOULD WEAR A COMFORTABLE SHIRT, SHORTS AND TENNIS SHOES WITH HAIR PULLED BACK NEATLY INTO A PONYTAIL. NO, TEAM'S LOGO OR BRANDING TO BE WORN. ABSOLUTELY NO JEWELRY IS ALLOWED. WHITE TOP AND BLACK BOTTOMS ARE PREFERRED.

Q: CAN MY CHILD BE A PART OF CAO WHILE STILL PARTICIPATING ON HIS OR HER SCHOOL CHEERLEADING TEAM?

A: WE SUPPORT OUR ATHLETES' INVOLVEMENT IN OTHER EXTRACURRICULAR ACTIVITIES (I.E., YOUTH/SCHOOL CHEERLEADING, OTHER SPORTS TEAMS) AS LONG PARTICIPATION DOES NOT CONFLICT WITH THEIR RESPONSIBILITIES OR THEIR COMMITMENT TO CAO. PARTICIPATION MUST BE DISCUSSED WITH OUR COACHING STAFF TO DETERMINE ANY POTENTIAL CONFLICTS.

Q: MY CHILD GOES AWAY DURING THE ENTIRE SUMMER WILL THIS BE A PROBLEM?

A: YES. WHILE PRACTICES ARE NOT MANDATORY DURING THE SUMMER ALL CHOREOGRAPHY CAMPS AND SIZING DATES ARE. NOTHING WILL BE ORDERED FOR A CHEERLEADER THAT IS NOT SIZED, AND A PLACE IN CHOREOGRAPHY WILL NOT BE HELD. WE WILL ADD THEM IN AT THE COACHES' DISCRETION.

Q: ARE FEES PRO-RATED FOR CANCELLED PRACTICES?

A: NO. WE WILL HAVE ENOUGH CALLED PRACTICES, ADDITIONAL COMPETITION PRACTICES, AND LOCK-INS TO MAKE-UP FOR ANYTHING THAT IS MISSED. IT ALL WEIGHS ITSELF OUT. WE DO NOT CHARGE FOR ADDITIONAL PRACTICES SO WE DO NOT PRO-RATE.

Q: WHO HANDLES MY ACCOUNT FINANCIALLY?

A: THE OWNER HANDLES ALL BILLING AND PAYMENTS, HOWEVER THE TEAM REPS WILL RECEIVE REPORTS ON UNCLEARED ACCOUNTS FOR THEIR TEAM IN EFFORTS TO
1. COLLECT THE FEES 2. HAVE FULL TEAM PARTICIPATION. 3. PROVIDE AID OR ASSISTANCE IF APPLICABLE.

Q: WHY IS THE FEE SCHEDULE THE SAME FOR PREP AND ELITE?

A: TYPICALLY OUR PREP TEAMS WILL DO MORE COMPETITIONS THAN ELITE TEAMS MAKING UP FOR THEIR ONE-DAY EVENTS. IN RETURN WE GIVE THEM ANOTHER COMPETITION.

Q: HOW DO YOU DECIDE WHICH TEAM IS PREP VS. ELITE?

A: WE MAKE THESE DECISIONS DURING CHOREOGRAPHY CAMP BASED ON THE KIDS READINESS AND RETENTION LEVEL. WE FIND JOY IN THE PREP LEVEL DIVISION FOR GIRLS THAT HAVE NEVER EVER CHEERED!

Q: DO YOU EXPLAIN SCORESHEETS TO THE PARENTS?

A: NO. I WILL SHARE SCORES, BUT I DO BELIEVE THERE IS THIN LINE THAT HAS TO BE RESPECTED BETWEEN COACHING AND PARENTING. HOWEVER WE GIVE THE SCORESHEETS TO OUR TEAMS TO READ THEIR NOTES FROM THE JUDGES AND SEE THEIR SCORES.

APPLICATION OF PAYMENTS: Seller will apply all payments received to pay installments (including late charges, if any) in the order in which they are scheduled to be paid.

DISHONORED DRAFT FEE: If a draft or order for payment of money on any bank or other depository submitted by the Buyer to Seller as payment is not honored by the bank, then the Seller may add a \$25.00 or an amount equal to the actual charge by the depository institution for the return of any dishonored instrument, whichever is greater, the following occurs to the unpaid balance under the Agreement.

DEFAULT: You are in default if the following occurs and your membership can be terminated if: (A) We do not receive an installment payment from you, your bank, or credit company on or before the date it is due; or (B) You fail to fulfill any obligations or promises under the Agreement including but not limited to full compliance with the Gym Rules and Regulations.

ACCELERATION OF PAYMENTS: If you are in default in the Agreement, quit or are removed for any reason Seller can immediately without notice demand payment of all unpaid installments.

ATTORNEYS FEES AND COURT COST: If your failure to pay any one or more of the installments due under this Agreement results in the Seller retaining an attorney or collection agency for the collection of the installments due hereunder, you shall be responsible for the payment of the collection fees court cost and all attorney's fees incurred.

There are no grace periods for any payments. Payments are due by midnight on their due date or subject to a \$35.00 late fee. Accounts that remain past due after the 1st of the next month are subject to an additional \$35.00 late fee and up to removal from the floor until balances are brought current.

RULES AND REGULATIONS: (see rules and guidelines handbook) I understand that violations of the rules and regulations may cause my membership with the Gym to be immediately terminated at the discretion of the Seller. WAIVER AND EXEMPTIONS: The Buyer waives, as to the debt incurred in this Agreement or any extension hereof, all rights of exemptions as to personal property allowed under the United States Constitution, the laws of the State of Georgia or any other state.

LIABILITY WAIVER: It is expressly agreed that all of the use of the Gym and its facilities shall be undertaken by the Buyer at his or her risk. It is further agreed that the Seller shall not be liable for any injuries or damage to the Buyer or guest, nor the property of the Buyer or guest, nor be subject to any claim, demand injury, or damages whatsoever, including but not limited to damages resulting from acts of active or passive negligence on the part of the Seller, its successors or its officers or agents. It is specifically agreed that the Seller shall not be responsible or liable to the Buyer or his or her guest for articles lost or stolen in the Gym. The Seller shall not be responsible or liable for loss or damage to any other property of the Buyer or his or her guest, including their automobiles and the contents thereof. It is also agreed that any damages to the Gym facilities or property or to the property of any Buyer and by another Buyer or his or her guest, it is the sole responsibility of the offending Buyer.

The Buyer agrees that he or she is responsible for any damages caused by the Buyer to the Gym and its facilities and equipment and for any personal injury or property damage caused by the Buyer to any other Buyer, guest, or property of either, and the Buyer agrees to indemnify and hold harmless the Seller for any loss caused by the Buyer for which the Seller is accused or held liable including attorney fees and court cost.

SHOULD YOU (THE BUYER) CHOOSE TO PAY FOR MORE THAN ONE MONTH IN ADVANCE, BE AWARE THAT YOU (THE BUYER) ARE PAYING FOR FUTURE SERVICES AND MAY BE RISKING LOSS OF YOUR MONEY IN THE EVENT THE GYM/AND OR BUSINESS LOCATION CEASES TO OPERATE. THIS GYM IS NOT REQUIRED BY GEORGIA LAW TO PROVIDE ANY SECURITY, AND THERE MAY NOT BE OTHER PROTECTION PROVIDED TO YOU (THE BUYER) SHOULD YOU CHOOSE TO PAY IN ADVANCE.
